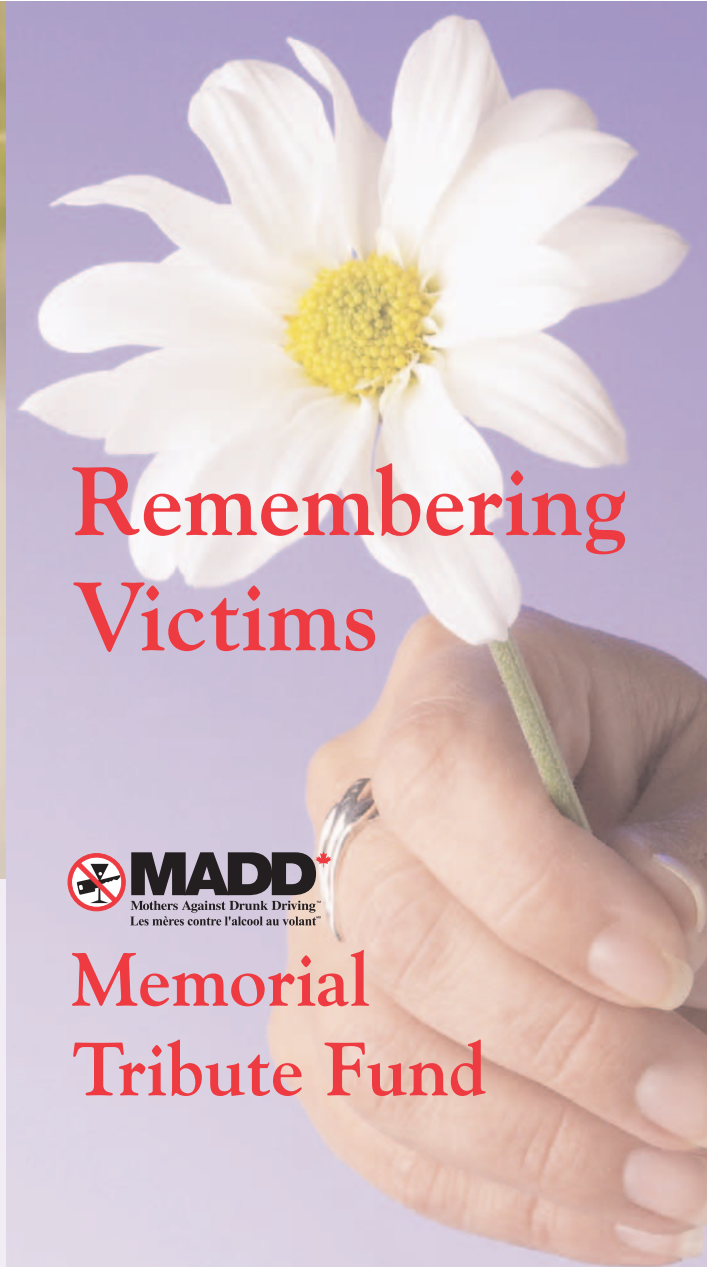

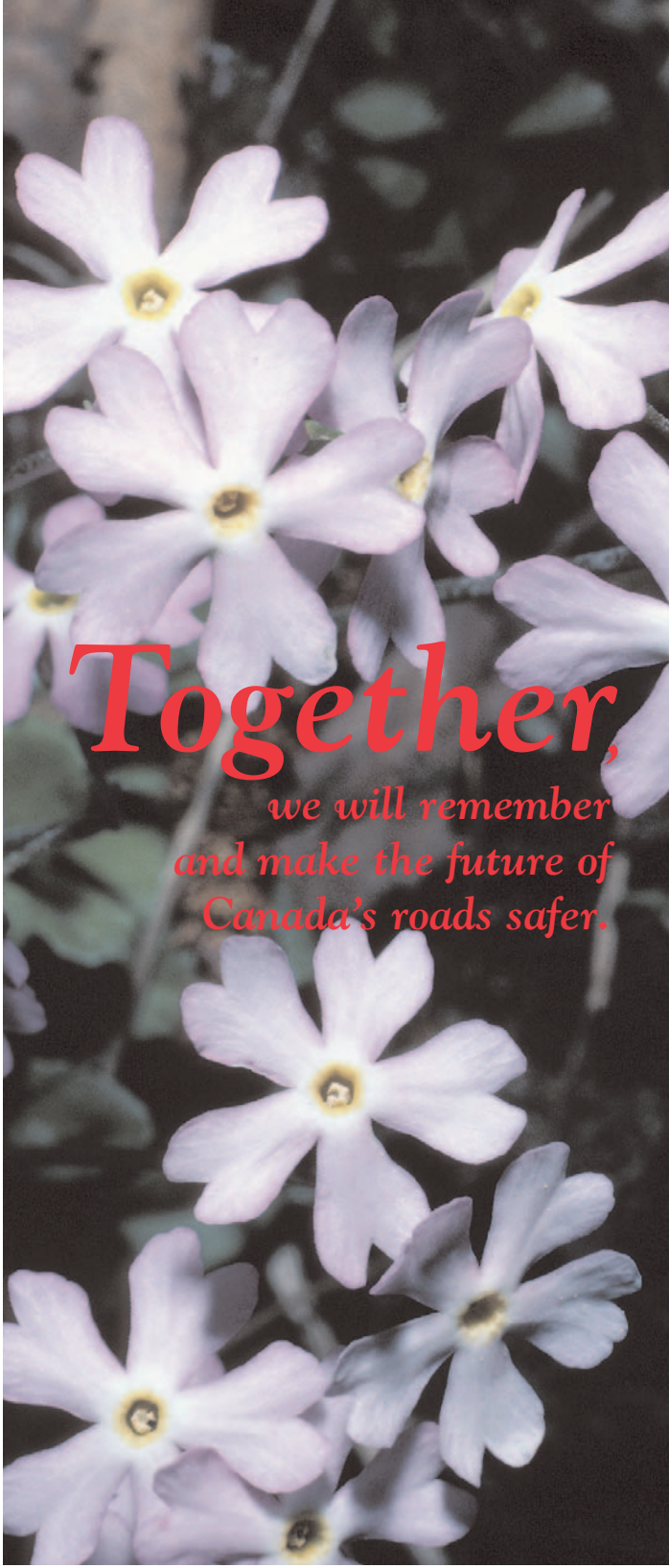

## What is MADD Canada's Memorial Tribute Fund?

A Memorial Tribute Fund is a fund set up in the name of your loved one which celebrates and commemorates their life. It provides a way for family and friends to donate or raise money for MADD Canada in a way that is appropriate to them, in memory of their loved one. There is no minimum donation. A Memorial Tribute Fund inspires hope that some good continues to develop from such a loss.

## Why has MADD Canada set up Memorial Tribute Funds?

We set up Memorial Tribute Funds as a lasting way to commemorate the life of someone special, your loved one, while raising money to help fight impaired driving and support victims of this violent crime. The funds raised will support MADD Canada's efforts and provide hope that there will be a future without victims of impaired driving.

## How do I set up a Memorial Tribute Fund in memory of my loved one?

When you make a donation in memory of your loved one, you can establish a Memorial Tribute Fund in their name to honour their memory. It's very easy to set up and we handle all of the administration. Family and friends make donations to the Memorial Tribute Fund on an ongoing basis, perhaps to celebrate a birthday, anniversary, or special occasion. It's a long term fund so you can watch it grow for years and years.

## How can you help grow your Memorial Tribute Fund?

You can make a single donation or you can choose to join the Monthly Donor program in support of your Memorial Tribute Fund. Let your family and friends know about this Memorial Tribute Fund set up in memory of your loved one so they can also donate to it. Anyone can contribute to the Fund in whatever way they wish – through a regular gift perhaps, or by holding a special fundraising event.

Every contribution made will act as a tribute, while giving important support to the work of MADD Canada.

There are many ways you can help grow your Memorial Tribute Fund – the opportunities are endless. In addition to your single donation or monthly donor support, you might consider the following to support your Fund:

- Organize a collection at work, amongst friends, or at church;
- Leave a gift in your Will;
- Make a donation on Mother's Day; and,
- Make a donation in lieu of presents; for example, when holding a birthday party, ask guests to support your Memorial Tribute Fund instead of bringing presents.
